OPTIONS FOR COMMUNITY PARTNERSHIP

ACTION VC is a tax-exempt charitable organization under Section 501(c)(3) of the Internal Revenue Code ("Code"), Tax ID #20-3883656. Our mission is to serve the vulnerable in the local communities. Below are the options for Community Partnership, in which the participating organization/business will volunteer to make a tangible difference in their local community. Along with your volunteer service, your financial support will help us keep our services free and available for those in need!

1. PHILANTHROPIC PARTNER

- ACTION VC plans and coordinates a Local Love Day for employees/school groups.
- ACTION VC provides vetted projects (depending on the number of volunteers and their skills).
- ACTION VC handles publicity, project coordination and administration, and volunteer training and arrangement of other volunteer needs* (water, food, t-shirts, etc.)
- ACTION VC identifies skills and material needs and establishes project leaders.
- ACTION VC covers liability for volunteers and provides legal/insurance documents.
- ACTION VC promotes organization on our website as a community partner together with social media, and local newspaper promotion.

Suggested Contribution: \$1,500

2. MISSIONAL PARTNER

- ACTION VC plans and coordinates a Local Love Day for churches/nonprofits.
- ACTION VC provides vetted projects (depending on the number of volunteers and their skills).
- ACTION VC handles project coordination and administration, and volunteer training.
- ACTION VC identifies skills and material needs and establishes project leaders.
- ACTION VC covers liability for volunteers and provides legal/insurance documents.

Suggested Contribution: \$1,000

3. COMMUNITY SPONSOR

- Company listing posted on ACTION VC website as a corporate partner together with social media, and local newspaper promotion.
- Thank you and recognition at events.

LOCAL LOVE DAY EVENT TIMELINE

TWO MONTHS OUT → PLANNING AND AGREEMENT

1. Partner submits Service Day Request Form, (includes project preferences, # of volunteers, area of town they want to serve).
2. Both parties sign Partnership Agreement.
3. Partner submits suggested contribution.
4. Orders for optional needs (food/water) are placed.
5. Project Coordinator begins to arrange projects that fit the organization's size and needs.

ONE MONTH OUT → PROJECT COORDINATION

1. Project Coordinator submits a range of project options to Partner. (*Project Ideas Examples:*)
 - a. Transitional Homes: community garden/grounds keeping, feeding meals .
 - b. Local Schools: painting murals/classrooms, preparing for fall semester.
 - c. Individuals: fire hazard clean up, painting, minor repairs.
 - d. Foster Youth: activity day or basket making.
 - e. Community: park, beach, street clean-ups.
2. Partner selects preferred projects.
3. Project Coordinator begins to arrange details.

THREE WEEKS OUT → PUBLICITY

1. Press Release is submitted to major news contacts.

TWO WEEKS OUT → PROJECT CONFIRMATION

1. Project coordinator submits finalized details to the project leader, including:
 - a. Project site Information (address, contact info, project details, etc.)
 - b. List of needed supplies.
 - c. Volunteer Handbook, Waiver, and Training Video.
2. Partner gathers needed supplies to complete the project(s).
3. Partner confirms # of volunteers serving.

ONE WEEK OUT → DETAILS FINALIZED

1. Project Coordinator confirms details with Partner.
 - a. Project start time.
 - b. Food/beverage set up (if needed.)
2. Partner submits list of volunteers to project coordinator.
3. Volunteer waivers are turned in, and all volunteers have completed training.

DAY OF → SUPPORT

1. ACTION VC representative visits project site(s), encourages volunteers, provides leadership support, and takes pictures.
